2. Discuss and approve the proposal to decrease the Company's share capital by canceling 50 million shares with a book value of AED 50 million (from AED 285 million the Company's current share capital to AED 235 million). The value of the reduction will be returned to the Shareholders because the company does not need it, and the amendment of the Article (6) of the Company's Memorandum of Association accordingly.
